## CIRCULAR

Subject :- Regarding online admission process under Freeship/EWS category in classes from 2nd onwards against available seats in Private Unaided Recognized Schools of Delhi for the academic session 2024-25

As per Section 12(1)(C) of RTE Act, 2009, all Private Unaided Recognized Schools are under obligation to admit at the entry level classes, to the extent of at least 25% of the strength of that class, children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion.

In WPC No. 4607 titled as "Justice for all Vs Directorate of education, GNCTD Hon'ble High Court of Delhi has observed that seats available under EWS category in the classes from 2nd onwards will be filled and department has also given its consent to develop a mechanism to fill these vacant seats of EWS category in the classes 2nd onwards.

Earlier, the Private Unaided Recognized Schools (Except minority) running on the land allotted by DDA/other Government agencies had been following the manual procedure for admission of Economically Weaker Section in neighborhood to the extent of 20% in the fresh admissions in classes 2nd onwards in accordance with the Notification dated 30.12.2013 and order dated 28.04.2016.

Further, vide circular of DoE dated 27.07.2018, it was decided to fill all such vacancies/ seats available under free-ship quota through computerized draw of lots after inviting online applications in the similar manner as is being done in case of admissions at the Entry Level classes under EWS/DG category in Private Unaided Recognized Schools (except minority schools).

During the session 2022-23 & 2023-24, department had already conducted online admission process for Freeship/EWS category in classes from 2nd onwards against available seats in Private Unaided Recognized Schools running on Govt. land for the candidate under EWS/Freeship category. This year department has also adopted the same process for admission under EWS/Freeship category from classes 2nd onwards against available seats in Private Unaided Recognized Schools of Delhi for the session 2024-25.

Now all DDEs District are directed to collect the data of actual vacancies as on date or probable vacancies in the academic session 2024-25 due to addition of new section or addition of general/open category seats in the existing section for 2nd onwards classes under Freeship/EWS quota from all the Private Unaided Recognized Schools running on land allotted by DDA or any other Govt. agency, for the session 2024-25 and get the provided data authenticated with the help of DE nominees & DDEs Zone.

The above exercise must be completed by 10.07.2024 (Wednesday) without fail and the districts may forward the authenticated data (in the attached Proforma), in hard copy as well as soft copy (in excel format) to Private School Branch, DoE, Old Sectt, New Delhi so that further necessary action can be taken for starting online admission process for 2nd onwards under Freeship/EWS quota, for the academic session 2024-25, well in time,
