CIRCULAR

Sub: Providing of relevant information, Court orders, process information and relevant documents for free & fair conduct of GSTA Election.

The undersigned has been appointed as Returning Officer (R.O.) to ensure free & fair conduct of GSTA Election vide Regional Director of Education (Awards/Welfare), Awards Branch, DoE Order No. F. DE.23(134)/Awards Br./2024/1246-1251 dated 25.06.2024.

In W.P(C) 6200/2024 filed by Loktantrik Adhyapak Manch and W.P(C) 2101/2024 by GSTA Delhi against GNCTD & Ors. It is mentioned in para 6 that

"Respective Counsel for the parties are in agreement that a General Body Meeting would be called by GSTA in which the membership/voter's list of the GSTA would be finalised and further, the same shall be forwarded to the Returning Officer, who shall verify the voter's list and take steps for holding the election."

Para 7- "Respective counsel for the parties jointly submit that the Returning Officer shall be requested to conclude the election process by the end of October 2024, it is directed accordingly"

The said GSTA Election process is being initiated in compliance to Hon'ble High Court order as above.

In this regard, all concerned Head of Branches/Zones/Districts/RDE office/H.Q./Stakeholders (GSTA Election) Education Department are requested to provide the relevant information, records/facts/past Court orders if any, process related information/documents, suggestions and other relevant references available with them, past appointment orders/list of Zone/District wise Nodal Officers, records etc. which may facilitate the smooth conduct of GSTA Elections in a time bound manner.

Since, the last elections of GSTA were held approximately 10 years back, the desired information would enable the undersigned to conduct the duties of Returning Officer (R.O.) efficiently so as to facilitate the conclusion of GSTA Election. Any information in this regard may please be provided on the e- mail or in hard copy (self attested) to the office of the undersigned.


