Subject: Completion of UDISE+ Data for year 2024-25 by 15th December, 2024.


With reference to D.O. Letter No 23-2/2024-Stats (Part 1) dated 03 December, 2024 received from Department of School Education & Literacy, Ministry of Education, Govt. of India regarding completion of UDISE+ Data for year 2024-25. UDISE portal for 2024-25 data entry was opened on 1.4.2024 with a request to be completed by September 2024. As of now, still the progress of the data entry of many States/UTs is very dismal. A copy of D.O. letter of even no. dated 28th March, 2024 is **attached as Annexure-A**.

The Ministry of Education has requested to exercise utmost care while filling the UDISE 2024-25 data and complete the same before 15th December, 2024 so that latest data can be utilized for PAB 2025-26.

In this regard, Circular No: DE (29)(19)(10)/SS/PI/UDISE+/2022-23/299-310 was **issued (Copy attached as Annexure-B)** to All Heads of Schools of all managements ((DOE, DoE Aided, DoE Un-Aided, MCD, MCD Aided, MCD Un-Aided, DCB, NDMC, DSW and Jamia) under Education Department, Delhi.

All HoS are directed to check/ensure the data regarding UDISE Plus, school information, teachers and student enrolment Accuracy of data must be maintained while filling online UDISE data at www.udiseplus.gov.in . The authenticity of data entered at the school level is of critical importance and Head of School shall be accountable.

Therefore, all DPOS/DDEs are directed to ensure that DDE Zones, DURCCS, CRCCS including himself/herself have checked/authenticated the correctness of the online UDISE plus data and Online certificate of Head of Schools for the session 2024-25 before 15th December, 2024 and DPOs/DDEs (District) will submit the duly signed Verification Certificate on 20th December, 2024 by 05:00 PM in the office of Samagra Shiksha-Delhi (HQ).

Dear Additional Chief Secretary/Principal Secretary/Secretary,

May recall the issues discussed in the meeting held on 27.11.2024 with State Education Secretaries/ State Project Directors regarding conduct of forthcoming "PARAKH Rashtriya Sarvekshan (PRS) 2024" by Department of School Education & Literacy (DoSE&L).

2. As informed in the meeting, UDISE+ 2023-24 data has been used as sampling frame for selection of schools for PRS, as UDISE+ 2024-25 data is not yet filled by many states. It was brought out that, since then, there have been changes in Medium of Instruction (MoI), schools with zero or less than 5 enrolment and school merged or closed in the PRS sampled schools. It was also noted that, these issues pertain to some states who were providing backend data for long and migrated to UDISE+ recently. It was also brought to your notice that, DoSE&L in every monthly meeting reiterated the need for accurate data entry in UDISE+ for effective scheme implementation, monitoring and has made series of presentation before State Education Secretaries. Further, State wise Presentation were also prepared by DoSE&L and shared with States/ UTs highlighting State specific problems like zero enrolment schools, small size schools, medium, attendance of students, students' performance in board exam etc for optimal utilisation of limited resources with a view to promote ease of schooling.

3. You are aware that, UDISE+ portal for 2024-25 data entry was opened on 1.4.2024 with a request to be completed by September, 2024. As of now, still the progress of the data entry of many States/UTs is very dismal. A copy of D.O. letter of even no. dated 28th March, 2024 is **attached** for reference. Since, the sampling frame was designed using UDISE+ 2023-24 data and if the state had completed 2024-25 data in time, this problem of change in MoI, etc could have been avoided to some extent.

4. In the light of above, I look forward to your personal attention and intervention in issuing suitable instructions to the authorities to exercise utmost care while filling the UDISE+ 2024-25 data and complete the same before **15th December, 2024 so that we can utilise latest data for PAB 2025-26**. I would deeply appreciate if you could accord it **TOP PRIORITY**.

Dear Additional Chief Secretary/Principal Secretary/Secretary,

I am writing to you in connection with opening of the portal for next round of UDISE+ for the year 2024-25 so as to align the data collection mechanism with academic year itself.

2. The portal for data entry of UDISE+ 2024-25 will be opened for States/UTs on **1st April, 2024**. It is expected that State/UT will complete the data entry by **31st July, 2024** and complete the final certification within two months i.e., **30th September, 2024**. W.e.f 2024-25, UDISE+ portal will also have an added facility of Student's Attendance and Teacher's Registry which will facilitate State/UT for monitoring student's attendance and teacher's deployment more effectively.

3. To enhance the coverage of enrolment and achieve 100% Gross Enrolment Ratio (GER) as envisaged in NEP 2020, a Data Capture Format (DCF) to capture enrolment data in the age group 14 to 17 years of students enrolled in National Institute of Open Schooling (NIOS) has been designed in consultation with NIOS and data being filled by NIOS centres in 2024-25. Moreover, to capture the enrolment data of institutions imparting non-formal education (without UDISE code) viz., private pre-primary schools, unrecognised schools, standalone skill centre, a provision was made in DCF at BRC/ CRC level to fill the summary data of such institutions. This was already informed vide D.O. Letter No. 23-7/2022-Stats dated 23.03.2023. A copy of the letter is attached for reference. However, many State/UT are not utilising this facility properly and need to look into it.

4. As you are aware that as per the provisions of RTE Act, it is mandatory on the part of the local authorities to maintain the data and record in prescribed performa. To meet the requirement of RTE Act, UDISE+ has been developed to maintains data and provide unique UDISE+ Code to schools to meet the requirement of RTE provisions. Thus, non-submission of data in time in UDISE+ is leading to violation of RTE Act.

5. I have also been informed that inspite of several reminders/ correspondences, some State/UT are yet to complete the UDISE+ 2023-24 and complete clearance of duplicate data and Drop Box issue. This needs to be addressed **without any further delay**.

6. In the light of the above, I request you to sensitise the state machinery to start data collection to meet deadline. I am attaching Data Capture Format (DCF) of 2024-25 with a request to take immediate action to start filling the data in portal.

Dear Additional Chief Secretary/Principal Secretary/Secretary,

Kind reference is drawn to the D.O. Letter dated 14.11.2022 regarding inclusion of additional indicators to be filled at BRC level before final certification in UDISE+ portal. A copy of letter is enclosed for ready reference.

2. I would like to reiterate that the purpose to include these additional indicators (total enrolment in unrecognized schools, private pre-primary schools, skill/ vocational/ ITIs under the purview of State Government) are to capture the enrolment data presently not captured in UDISE+. Department of School Education & Literacy (DoSE&L) is the Nodal and Line Ministry in respect of educational indicators in many Global Indices including "Human Development Index (HDI)" and "Human Capital Index (HCI)" and one of the oft used educational indicator used in most of the Global Indices is "Expected Years of Schooling (EYS)" in which, numerator is the summation of enrolment data.

3. You may acknowledge that the present enrolment data captured through UDISE+ is itself not sufficient as there are various Schools/ Institutions/ Organisation that are under the purview of State Government, which are imparting some form of education and whose enrolment data is not being captured in UDISE+. Therefore, to improve India's rank in Global Indices, it has been decided to capture the enrolment data covered under State Government purview though UDISE+. **This will potentially be the game changer in improving India's rank in Global Indices.**

4. It is also brought to your notice that the last date for completion of data entry in UDISE+ 2022-23 is already over and review suggests that still the progress of your State/UT is very slow. As you are aware that DoSEL has introduced student wise data collection from 2022-23 and its significance has been emphasized in many deliberations including the Chief Secretary Conference held recently. Since, the financial year is about to be over, I urge you to intervene in the matter in making UDISE+ successful and complete.

5. In view of above, I look forward to your personal attention and intervention in issuing suitable instructions to the authorities to complete UDISE+ 2022-23 before **31st March, 2023**. I would deeply appreciate if you could accord it **TOP PRIORITY**.

Sub: UDISE+ DCF 2024-25 submission and declaration by Head of School and verification/authentication by CRCCs/ DURCCs/DDEs Zone/Districts Online for UDISE+ 2023-24 at www.udiseplus.gov.in .

All Heads of Schools of all managements ((DOE, DoE Aided, DoE Un-Aided, MCD, MCD Aided, MCD Un-Aided, DCB, NDMC, DSW and Jamia) under Education Department, Delhi to submit the Certificate of Completion of UDISE+ data for the year 2023-24 to DDE District/DDE Zone **by 03.05.2024. Deputy Director of Education of all District will submit the hard copy of Three Certificates of their District, namely School Profile & Facility, Teachers Profile and Student Profile to State Project Director, Samagra Shiksha-Delhi latest by 06.05.2024.**

The DDEs (District) will also organize a training on UDISE+ for year 2024-25 for all HoS of all management schools of their District and then start entry of data in the portal of UDISE+ 2024-25.

It is expected that Heads of Schools of all managements under Education Dep (DOE, DoE Aided, DoE Un-Aided, MCD, MCD Aided, MCD Un-Aided, DCB, NDMC, DSW and Jamia) under Department of Education will complete the data entry upto 31st July, 2024 and complete the final certification within two months i.e. 30th September, 2024.

All HoS are directed to check/ensure the data regarding UDISE Plus, school information, teachers and student enrolment. Accuracy of data must be maintained while filling online UDISE+ data at www.udiseplus.gov.in. The authenticity of data entered at the school level is of critical importance and Head of School shall be accountable for the same.

Therefore, all DPOs/DDEs are directed to ensure that DDE Zones, DURCCs, CRCCs including himself/herself have checked/authenticated the correctness of the online UDISE + data and online certificate of Heads of Schools.

The DDE Zones, DURCCs, and CRCCs have to submit the verification Certificate online by 05:00 PM **on 31st July, 2024.**

Non compliance shall be viewed seriously as the data need to be uploaded on the portal in a time bound manner.
