Kala Utsav aims to foster and showcase the artistic talent of the student of Secondary Stage. This annual event provides a platform for students to explore and celebrate arts and cultural diversity at various levels-school, district, state and national.

In Kala Utsav 2024, there will be a few changes which will foster growth, flexibility and widen the scope of the whole event. Theme of this Kala Utsav will be: Viksit Bharat-A Vision for Bharat in the year-2047. The art forms have been grouped in many sub-categories under six broad categories- 1.Vocal Music, 2. Instrumental Music, 3. Dance, 4. Theatre 5. Visual Arts 6. Traditional Story Telling.

- 5. Participation of Socio-Economically Disadvantaged Group (SEDG) including Children with Special Needs (CWSN) at all levels to be ensured.
- 6. **Textual Summary Write-up-** (Required to be submitted by the winners of State Level only) Should not be more than **100 words in soft copy MS-Word document** in Hindi or English to be prepared by the participants by himself/herself giving details about the selected art form. The textual summary can be supported with Photographs (Max-5).
- 7. Instructions for National Level participation will be duly given to the first Position holders.
