4	Level in the Pay Matrix	Level -7 (Rs. 44900-142400/-) in the Pay Matrix
5.	Whether Selection or Non-Selection post	Selection
6	Age limit for Direct Recruitment.	Not exceeding 30 years. (Relaxable for Govt. Servants upto 05 years in accordance with the instructions or orders issued by the Central Govt.) Note: The crucial date for determining the age limit shall be as advertised by Competent Authority.
7	Educational & Other Qualifications required for Direct Recruitment.	<u>Essential</u> 1. Graduate Degree in Civil Engineering Discipline from a recognized Institute/ University. 2. Two Years professional experience in the field of Civil Engineering works in the scale not below Level-6 as per 7 th CPC in Central Govt./State Govt./U.T./PSU/Autonomous Body of Central Govt./State Govt./U.T. Note-1. Qualifications are Relaxable at the discretion of the Competent Authority in case of candidates otherwise well qualified.

		Note:2:- The qualification(s) regarding experience is/are Relaxable at the discretion of the Competent Authority in case of candidates belonging to SC or ST, if at any stage of selection the Competent Authority is of the opinion that sufficient numbers of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.
8	Whether age & Educational qualifications prescribed for Direct Recruits will apply in case of promotees.	Age – No EQ- 'NO', but possess at least a Diploma in Civil Engineering.
9.	Period of probation, if any	Two Year for Direct Recruits Note:- Direct recruits would be required to successfully complete a mandatory induction training of at least two weeks duration, as prescribed by the Competent Authority for completion of probation.
10	Method of recruitment whether by direct recruitment or by promotion or by deputation/absorption and percentage of the vacancies to be filled by various methods.	(1) 75% by Promotion failing which by deputation AND (2) 25% by Direct Recruitment
11	In case of recruitment by promotion/deputation/absorption, grades from which promotion/deputation/absorption be made	Promotion:- A. Junior Engineer (Civil.) with Five (05) years service in the grade rendered after appointment thereto on regular basis in the scale of Pay Level-6 (As per 7th CPC Rs. 35400-112400/-) or corresponding pre-revised pay scales. Note: The eligibility list for promotion shall be prepared with reference to the date of completion by the officer of the prescribed qualifying service in the respective grade/post.

Deputation:-

Officers in the Central/State Govt./Union Territories

(a) (i) Holding analogous posts on regular basis; OR

(ii) With 5 years regular service for degree holder and 8 years service for diploma holder, in the Pay Level-6 (As per 7th CPC Rs. 35400-112400 /-) or equivalent and

(b) Possessing a Degree / Diploma in Civil Engineering from a recognized university/institution

Note-1: The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation.

Similarly, deputationist shall not be eligible for consideration for appointment by promotion.

Note-2: Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Govt. shall ordinarily not exceed three years.

Note-3:- Where Juniors who have completed their qualifying/ eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than half of such qualifying/ eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying/ eligibility service.

		Note:-4 The maximum age limit for appointment by deputation/absorption shall be Not Exceeding 56 years as on the closing date of receipt of applications.
