**CIRCULAR**

While examining the agenda regarding clearance of memberships of persons of Ravi Shankar co-operative Group Housing Society Ltd. Dwarka, the Rule 90 Committee constituted in terms of Section 77 of DCS ACT 2003 & Rule 90 of DCS Rules 2007, has made the following observations:-

1. Before submitting the cases for consideration & approval of Rule 90 Committee, it shall be ensured that due procedures have been followed in granting the membership by the societies in terms of the extent provisions of DCS Act 2003 & DCS Rules 2007.
2. All details of members regarding their enrolment, resignation, expulsion & cessation shall be properly examined to ensure that no violation of provisions of DCS ACT2003 & DCS Rules 2007 has been committed at any level.
3. In cases where any record including proceeding register, membership register & other relevant record were lost and FIR has been lodged, details of police investigations and outcome of the Court order (if any) shall be brought on record for the consideration of the Committee with proper recommendations of the RCS Office.

All cases shall be re-examined where membership was transferred by nomination to ensure that no procedural violation committed in such cases in terms of extent provisions of law. It shall also be ensured that in cases where verification certificate (Form-F) are not found with details of date and signature of the applicant and attesting officer missing, fresh verification certificate shall be required by with proper details and dates with signature of attesting officer.

In cases where membership has been issued just after the attaining the age of majority, by member detail examination shall be carried out before recommending the names to the Committee.
