ORDER

In compliance with the order of Hon'ble Supreme Court of India dated 09.02.2009 in S.L.P. (Civil) No. CC 1281/2009 titled as Govt. of NCT of Delhi & Others Vs Association of Fire Service (Drivers), Delhi vide which judgment of Hon'ble Court of Delhi dated 13.05.2008 in the WP (C) No. 6194/2001 has been upheld for the grant of promotion to grade - I in the pay scale of Rs. 1600-2660 (Pre - revised) to the drivers who have completed 10 years of regular service in the pay scale of Rs. 1320 + 2040 and on the roll of DFS as on 01.01.1994.

Accordingly, the drivers who have been retired and admissible for the benefit of Grade - I on the basis of trifurcation of drivers who were in service in the year 1994 w.e.f. the date mentioned against their name.

As per the abovesaid judgment the drivers mentioned at Sl. No. from 3,6,8,12,22,30 & 32 who have completed 12 years regular service from the date of grant of Pay-scale of Rs. 1600-2660 (pre-revised) is hereby granted up-gradation in the pay-scale of Rs. 6500-10500 from the date mentioned against their name:-
