INSTRUCTIONAL ORDER

Subject:- Scheme for rebate on surcharge component of outstanding arrears of water charges.

In order to recover the arrears of water charges, Delhi Jal Board in its meeting held on 12.08.2010 vide Item No. 56 has approved a rebate scheme for grant of rebate on surcharge amount outstanding as combined arrears of water charges.

Quantum of rebate on amount of arrears of surcharge:-

Conditions for availing benefit of rebate scheme:-

1. The scheme for grant of rebate on outstanding surcharge shall be applicable to surcharge amount as outstanding at the end of 1st round of billing/2010-11 in the case of ½" water connections and 4th round of billing /2010-11 in the case of Bulk water connections.
2. The payment could be received in lump-sum or maximum four instalments of any amount not later than 31st December 2010. The rebate on the surcharge amount shall only be given when all the up-to-date dues of water charges have been cleared and not otherwise.
3. Those who want to avail the benefit of above scheme will make the requisite payment either in cash or through Bank Draft or Banker's cheque drawn in favour of "Delhi Jal Board". No personal cheque/private cheque will be accepted for availing the benefit of the rebate scheme. However, Govt. Institution/local bodies, Group Housing Societies, private reputed educational institutions and private hospitals/ nursing homes could deposit their dues vide cheques, also.
4. This scheme shall be operational from 01.09.2010 for a maximum period of four months i.e. upto 31.12.2010 and is the last scheme, after which no such rebate scheme is likely to be introduced.



The consumers should be advised to avail the benefit of above scheme at the earliest otherwise strict action for recovery should be taken against them.

The above scheme be brought to the notice of all revenue and engineering field staff for better implementation of the scheme. Performance of the revenue officials for the success of the scheme is crucial. Placards, display boards, camps etc be organised for awareness of the public as this is a one time opportunity for liquidating arrears at the zonal level.

Details of water connection wise summary of surcharge amount as per the approved rebate scheme wherever applicable will be sent to the concerned ZROs/Addl.ZROs by the Computer Cell before 31.08.2010, as such, the ZROs /Addl.ZROs need not wait for specific bills of 2nd round indicating the rebate on surcharge amount but can implement the scheme w.e.f. 01.09.2010 itself. Further, all ZROs/Addl.ZROs will maintain a register mandatory for the purpose.
