ORDER

Present Sh. S.P. Singh Sisodia appellant in person and Sh. Vikram Singh, Naib Tehsildar, Sh. Rajkumar, UDC on the behalf of PIO/SDM (Seemapuri).

Heard.

The appellant is aggrieved by the order of PIO/SDM (Seemapuri) on application dated 28.01.2010, ID No. 20023.

The appellant has sought information on the points mentioned in column 1 below and the PIO has given answer as mentioned in column 2 below.

S.No.	Question	Reply
1.	Information about appx. 3000 mtrs DDA land in DDA Colony, New Zafarabad (Opposite C-Block). The land is vacant and we need information about present status of the land and whether any project has been sanctioned on the same land or not.	A suitable reply cant be made due to incomplete information viz Khasra no. etc. is not given in the question.

During the hearing the appellant has shown me the copy of legal notice dated 21.01.2008 which is addressed to DC (NE) and Dir (Vigilance). In the said notice reference is given as under "our legal notice dated 11.1.2003 sent on behalf of may clients Ali Sher and others, Representation dated 3.2.2004 and application dated 5.12.2007 under RTI Act (copy enclosed)". Further the appellant points out that there is a file in the name of Ali Sher, Village Mandoli against Award No.1875.
