 - (e) Beginning of the Poll at 8.00 AM.
 - (f) Progress of the Poll at every two hours.
 - (g) Closing of Poll at 5.00 PM.
 - (h) Beginning of counting at 5.30 PM.
 - (i) Progress of counting at 7.00 PM onwards at every hour till the counting is completed.
