**ORDER**




**ORDER**

Absent Sh. Sudhir Kumar Appellant. Present Sh. M.L. Jain, PIO/LA.


The appellant is aggrieved by the order dated 20.09.2010 of PIO on application dated 07.09.2010, ID No.40013.
