This Appeal is filed on the ground that the P.I.O. has not provided the correct information of the questions (except question No.1) raised in above said RTI application.

From perusal of record it is evident that PIO has provided information to the appellant, however the appellant is not satisfied with the informations given. All the questions were discussed in detail. SDM, Seemapuri/ PIO stated that he has provided all the informations available in the records.

It is observed that the issues pertains to M.C.D., Industries Department, Pollution Control Committee, GNCTD in the said RTI application. PIO has only transferred the question No.9 to 12 to MCD for reply whereas other questions (Q.No. 2 to Q. No.8) have not been transferred to the concerned PIOs.

PIO/SDM, Seemapuri is directed to forward the RTI application to the concerned departments/PIOs for reply pertaining to their matters.

Further appellant is advised to submit written application to the SDM, Industries department etc. in respect of any particular grievances/problem for further necessary action by the department as per Law.
