Of Personnel & Training), the Divisional Commissioner/Principal Secretary (Revenue) is pleased to nominate the following officials for granting of financial up gradation after completion of 12/24 years of regular service as detailed below:

The financial up gradation shall be purely to the officials and shall have no relevance to their seniority position. As such there shall be no additional financial up gradation for senior officials on the ground that the junior officials in the grade have got higher pay scale under the ACP Scheme.

The pay of the above officials shall be fixed under the provisions of FR 22(1)(a)(i) subject to a minimum financial benefit of Rs. 100/- as per the DOPT OM No. 1/6/97-Pay I dated 5th July 1999. The financial benefit allowed under the ACP Scheme shall be final and no pay-fixation benefit shall be accruing at the time of regular promotion i.e posting against a functional post in the higher grade.

The officials concerned are allowed to exercise their option, if any under FR 22 within one month of the issuance of the order of granting the financial up gradation under the ACP Scheme.

The fixation of pay is subject to the post audit observations and over payment, if any, than entitlement, either in the form of arrears or otherwise, shall be recoverable without any notice.

The above up gradation will be further subject to the terms and conditions stipulated in the DOP&T OM No. 35034/1/97-Estt (I) dated 09.09.99.
