Sub:- Promotion of Assistant Teachers and Lab Asstts. of Directorate of Education to the post of TGTs/TGTs(MIL) in the Directorate of Education, GNCT of Delhi against the vacancies for the year 2009-2010.

Sir/Madam,

As per the provisions of Recruitment Rules (RRs) for the post of TGTs/TGT (MIL), 138 (91 Asstt. Teachers & 47 Lab. Asstts.) vacancies are available in different subjects / categories for promotion from Asstt. Teachers/ Lab Asstts., working in this Directorate having minimum 5 years regular service as Asstt. Teacher/ Lab Asstt. And who fulfill the requirements of RR as on 01.01.2010 vide this office letters dated 05.03.2010 & 19.03.2010. It was requested that the particulars of eligible Asstt. Teachers / Lab Asstts. having 5 years regular service who fulfill the prescribed qualifications as on 01.01.2010 may be forwarded to this office in the prescribed proforma by 16th April, 2010. **The cut off date of eligibility conditions shall be 01.01.2010** but dossiers/applications have not been forwarded in optimum numbers, as per vacancy available, from your office.

The Vigilance Clearance Report (VCR), Integrity Certificates (IC), ACR for the last five years 2004-2005 to 2008-2009, attested photo copies of marks sheets of graduation for all years and other certificates may also be enclosed along with the application. Incomplete application in respect of ACR/VCR/IC/WCR/ Snty No./ attested copies of marks sheets etc. will not be entertained.

In view of the above, it is requested that the particulars of eligible Asstt. Teachers / Lab Asstts. having 5 years regular service who fulfill the

prescribed qualifications as on 01.01.2010 may be forwarded to this office in the prescribed proforma **latest by 20th July, 2010.**

The consolidated list of applications may be forwarded on compact disk/workable floppy (Data in Excel) along with a hard copy as per proforma (Copy enclosed.) separately for male and female Asstt. Teacher duly signed by Competent Authority. The applications not included in the consolidated list will not be entertained. The District Authorities will be responsible for any incorrect information filled in the consolidated lists.

It is clarified that no previous list/applications will be considered for these posts and all the willing candidates will have to apply afresh in the modified proforma.
