
communication on the subject cited above, I am directed to convey the approval of the Competent Authority to the following addition below sub-para (i) of para 6 of the Scheme for S.A.S Examination annexed to this administration letter No. F.20/3/79-AC, dated 11.5.79-AC as amended from time to time :-

Addition below Sub-para (i) of para 6.

"All Group 'C' or Group 'B' non-Gazetted employees of Delhi High Court & District Courts working in the pay scale below Rs.6500-10500 will also be eligible for appearing in S.A.S/Common JAO Examination Part-I alongwith the employees of GNCT of Delhi as mentioned in the preceding para. Those officials of Delhi High Court & District Courts working in the pay scale equal or higher than Rs.6500-10500 and Group D employees are not eligible for appearing in the Examination."

Note:- However, it is made clear that the Delhi High Court & District Courts employees after qualifying the S.A.S/Common JAO Examination Part-I & Part-II will seek appointment in their own cadre and will not claim to be absorbed in the organized accounts cadre of GNCT of Delhi as per the undertaking given by Registrar General Delhi High Court vide letter dated 28.05.2003 and re-iterated by Registrar (Admn-Judl) Delhi High Court vide letter dated 21.7.2004 and also in accordance with the decision taken in the meeting held on 07.07.2004.
