ORDER

In continuation of earlier order No.F.5/SSS/CONV./AR-0708/1328-1448 dated 25.09.2008 and order No.F.29/MD/SSS/ Advt./08-09/Ind/4018-4034 dated 9.2.2009 (copies enclosed) issued in this regard, by the Mission Convergence (Samajik Suvidha Sangam) following revised procedure is prescribed for submitting the applications for entitlements and sanctioning thereof under various schemes.

- i) The Area MLAs/MPs shall continue to recommend the cases of Old Age Pension Scheme/Widow Pension Scheme/Financial Assistance for widow's daughter's marriage/National Family Benefit Scheme as before. However no ceiling/quota shall apply. The applications recommended by the Area MLAs/MPs shall be submitted to the Deputy Commissioner of the concerned district. On receipt of applications from the Area MLAs/MPs, the Deputy Commissioner of the District shall get further necessary verifications of the applications done from GRC-SKs which shall after verification resubmit the applications to the Dy. Commissioner Office for further action.

The eligible/entitled persons and households shall also continue to submit the applications for the entitlements under the above schemes directly to the GRC-SKs. After necessary scrutiny and verifications, the GRC-SKs shall submit the applications in the Dy. Commissioner Office (DMU/DRC) for further action. The Dy. Commissioner Office shall send the cases related to the Old Age Pension Scheme/Widow Pension Scheme/Financial Assistance for widow's daughter's marriage/ National Family Benefit Scheme to the Area MLA for his/her recommendations. The Area MLA shall, however, make his/her recommendations within a period of 30 days and send the cases back to the Office of Deputy Commissioner for taking further action. If any case is not received back in the office of the Dy. Commissioner within this period, it shall be presumed that the Area MLA has no objection to the sanctioning of the entitlements.



ORDER

Sub: Implementation of welfare entitlements through Mission Convergence (Samajik Suvidha Sangam).

In pursuance of Cabinet Decision No. 1372 dated 12/03/2008 a new scheme for facilitating the delivery of welfare entitlements has been launched under the name of "Samajik Suvidha Sangam". Further, in pursuance of Cabinet Decision No. 1421 dated 14/07/2008, a uniform criterion has been adopted for welfare entitlements schemes and identification of the vulnerable families. The abstracts of the important decisions taken in this regard are as under.

- a) To adopt social and occupational vulnerability criteria for the identification of the urban vulnerable using proxy indicators of income.
- b) To start first round of door to door survey through the existing GRCs for data collection in the respective catchment areas.
- c) To conduct survey of other areas by the new GRCs to be selected.
- d) To adopt a common form, with common eligibility criteria and documentation.
- e) To provide easy access and availability of forms to the citizens through the District Resource Centres, Samajik Suvidha Kendras, Gender Resource Centres and all field offices of converging departments and their website.
- f) To dispense with all other criterion, which were being followed hitherto, before 1st January, 2009, so that all the nine Departments covered under the Samajik Suvidha Sangam (Mission Convergence) adopt the new criterion.

2. Accordingly, an order No.F. 4/23/08/AR/8562 dated 27/08/08 was issued by the Administrative Reforms Department prescribing the guidelines to be adopted for the purpose of identification of vulnerable strata and the criteria for providing welfare entitlements by the nine departments covered under the scheme. (Annexure-1)

3. It has further been decided by the Cabinet that a comprehensive survey should be conducted for identification of the vulnerable families based on the new criteria. In pursuance to this decision, a detailed programme for conducting the survey has been prepared. The Department of Community Health, St Stephen's Hospital has been engaged as a Central Coordination Unit. A District Control Unit (DCU) has also been set up in each district. The Gender Resource Centers

(GRC) working as Peripheral Survey Unit (PSU) at community level have been associated with this work. A list of the DCU and PSU is at Annexure-II.

4. It has been decided that the nine departments covered under the scheme shall get 2.5% sample of households surveyed through the PSU for checking the integrity and quality of data and satisfying themselves about disbursement of entitlement to those covered by the survey.
5. The cabinet has also approved the rationalization of the existing welfare schemes of the nine departments covered by Mission Convergence vide decision No. 1451 dated 08/09/08 (Annexure - III) with the rider that the minimum residential criteria of 5 years, as prevalent for some of the schemes, should continue.
6. The steps taken for rationalization and the broad principles determining the same are as under:
 - a. Existing schemes of the nine departments have been mapped. The entitlements within each scheme have been mapped on one axis, with the vulnerable sections of Delhi on the other axis, with a focus to understand the suitability of each component of the scheme to meet the needs of the target population.
 - b. The gaps in the existing schemes to meet the needs of the vulnerable population have been identified, as per the new criteria approved by the Cabinet for a focussed and priority coverage. The gaps were identified on the basis of whether it meets the basic needs and entitlements of the various groups. An attempt has been made to strengthen the entitlements in each of the schemes so that it would be more appropriate for the benefit of each section of vulnerable population.
 - c. Some of the schemes and entitlements due to their unsuitability to meet the basic needs, are proposed to be wound up or schemes getting subsumed under more comprehensive entitlements have been merged. Merger of some schemes has been done in order to retain the focus of reaching out to the maximum number of vulnerable people. In addition, the coverage of certain schemes has been expanded for greater effectiveness and reach.
 - d. A progressive realisation of these entitlements has been made in a manner that the most vulnerable receive the greatest priority.
7. The cabinet has also approved the setting-up of an apex institution in the form of a registered society to converge provisions of nutrition, Hygiene and hot cooked meals for all the programmes of Govt. of NCT of Delhi. The Social Welfare Department shall be the nodal department for setting up such a agency, which would encourage active participation of Self Help Groups. A list of programmes is annexed (Annexure-IV).
8. In the light of the decisions of the Cabinet referred to above, the concerned nine departments are hereby directed to ensure compliance with the following directions:

- a. Each of the nine departments shall issue appropriate orders for adopting the new entitlement criteria for identification of beneficiaries for the programmes and schemes under their charge, so that the concerned officers and functionaries implement the same.
- b. Each of the nine departments shall take appropriate action to implement their schemes and rationalize them in accordance with principles/guidelines/matrix as approved by the Cabinet as in Annexure-III. The departments whose schemes are not incorporated in the matrix but are covered by Mission Convergence, shall take similar action, on the basis of these guidelines.
- c. Each of the nine departments shall take appropriate action for conducting test checks of the survey being carried out by the NGOs, running the GRCs for ensuring integrity and quality of the data.
- d. Each of the nine departments shall work out a scheme matrix, pertaining to their department showing which scheme would correspond to the 'Vulnerable' and 'Most Vulnerable' being identified by the survey under the new criteria.
- e. A common Application Form shall be devised by the PMU (Samajik Suvidha Sangam) which will be used for accessing any of the entitlements covered under the schemes of the concerned nine departments, keeping in view the common eligibility criteria. The form shall contain a list of all the entitlements covered under the convergence scheme, so that the applicant can tick mark the same. The form would seek the barest minimum information, essential to meet the criterion for accessing the required benefits. Information not required with the adoption of new criteria, shall be dispensed with. The form shall be devised in consultation with the concerned departments in a time bound manner so that the same can be adopted at the earliest.
- f. The beneficiaries/applicants should be required to submit the minimum supporting documents, to stake his claim; other documents, hitherto being asked for, should be dispensed with keeping in view the new common eligibility criteria.
- g. Each department shall take necessary action to cover the Central Government sponsored schemes, being implemented by them, by supplementing the financial requirements from the state government funds. Similar action needs to be taken in respect of other state funded schemes, so as to meet any enhanced demands.

8. The Social Welfare Department shall take immediate action for setting up a separate agency for bringing convergence of supplementary nutrition programme and other hot cooked meal programmes of various departments and for ensuring quality systems.
9. Action taken report should be sent to Pr. Secretary (AR)/Managing Director (Samajjik Suvidha Sangam) on a monthly basis so that the progress can be reviewed by the State Convergence Forum.


