**ORDER**

In continuation of this directorate order No.F.24(2007)/ACP-C.I./Trg.Admn./583 & 584 dated 25/07/2008, No.F.24(2007)/ACP-C.I./Trg.Admn./941 & 943 dated 14.09.2010, No.F.24(2007)/ACP-C.I./Trg.Admn./769 dated 25.09.2009, F.24(2009)/MACP-ACP-WSA/Trg.Admn./614 dated 05/07/2011, No.F.24(3)/ACP-C.I./Trg. Admn. (2010)/ 705 dated 14.07.2011 and F.24(2009)/MACP-ACP-WSA/Trg.Admn./758 dated 25/07/2011 vide which the 1<sup>st</sup> financial up-gradation under ACP was granted in the pay scale 5500-175-9000 (pre-revised) with effect from the due date and up to 02.07.2007 and in the pay scale of Rs. 6500-200-10500 w.e.f. 03.07.2007 as per the existing hierarchy/newly amended and notified recruitment rules for the post of Group Instructor notified dated 03.07.2007.

As per the directions dated 18.02.2011 of the Hon'ble Central Administrative Tribunal (CAT), Delhi vide OA No. 1233/2009 in the matter of Sh. Ram Narain and others V/S GNCTD & Others and in the consultation with the Law Deptt., GNCTD & ACP Cell (Services Deptt.) GNCTD, 45 officials were granted first financial up Gradation under ACP in the Pay Scale of Rs. 5500-9000(Pre- revised)/Rs. 6500-10500(Pre-Revised) vide letter No. F.153/DTTE/LIT.CELL/09/ 1252 dated 15.11.2011. The same benefits have been extended to the following officials w.e.f the dates as detailed below (Table A & B):-




