**ORDER**

In continuation of this directorate order No.F.24(2007)/ACP-C.I./Trg.Admn./583 & 584 dated 25/07/2008, F.24(2009)/MACP-ACP-WSA/Trg.Admn./614 dated 05/07/2011 and F.24(2009)/MACP-ACP-WSA/Trg.Admn./758 dated 25/07/2011 vide which the 1<sup>st</sup> financial up-gradation under ACP was granted in the pay scale 5500-175-9000 (pre-revised) with effect from the due date and up to 02.07.2007 and in the pay scale of Rs. 6500-200-10500 w.e.f. 03.07.2007 as per the existing hierarchy/newly amended and notified recruitment rules for the post of Group Instructor notified dated 03.07.2007.



Consequent upon the above up gradation/revision, the pay of above mentioned officials is to be fixed under the provision of FR-22(i) (a) (1) subject to minimum financial benefit of Rs. 100/- as per the DOPT OM No.1/6/97 Pay-1 dated July 5<sup>th</sup> 1989. The financial benefit allowed under the ACP scheme shall be final and no fixation benefit shall accrue at the time of regular promotion i.e. posting against a functional post in the higher grade. The option of pay fixation in the higher grade from the date of next increment may be exercised within 30 days as per provisions of FR 22(I) (a) (1).

The above officials are eligible for interest @ 9% per annum on the arrears from the date the amount became due, till payment thereof. The expenditure involved as arrear on this account will be met by the concerned ITIs/BTCs from their functional Major Head (Non-Plan/Plan) and expenditures involved as 9% interest per annum on the arrears will be met by the concerned ITIs/BTCs from their functional Major Head (Charged Sub-Head)(Non-Plan/Plan).


