INSPECTION OF THE RESTAURANT

May kindly see the letter dated 09.04.08 in above said reference received from the DHO (SZ). The restaurant was inspected by undersigned to ensure the suitability of the of the existing fire safety measures in the restaurant. Manager with other staff of the restaurant was also present at the time of inspection.

During the course of inspection, it has been observed that the eating house/restaurant is being run at the ground floor with the two exits. The building is accessible to fire engines in case of emergency through a road of sufficient width. The existing fire safety arrangements with respect to the circular no F6/DFS/MS/EH/2005/718 dated 4/4/2005 were found provided such as: - Hose reel, Manual fire alarm, overhead water storage tank, Fire pump, ISI marked fire extinguishers of different type and cap., Emergency Light with battery back up, illuminated Exit signs, smoke venting arrangements, Emergency supply. Electric wiring is concealed type. MCBs/ELCBs on Main and distribution electric circuit were also provided. The above said equipments/system were checked/operated and found functional at the time of inspection.

In view of the above said observations of fire safety directives / measures as found during the above said inspection, the fire clearance /NOC for the renewal of license for restaurant part/area may be considered from fire safety angle by this deptt. The letter on above lines is prepared accordingly for approval and signatures (if approved).
