May kindly peruse the letter No.23870-74/Addl.C.P/lic.(H), dated 03.6.2011 received from Addl. Commissioner of Police (Lic.) regarding NOC from fire safety and means of escape point of view for grant of of license to run a guest house in the name and style of J.P. Inn located at 5/2, East Patel Nagar, New Delhi-110008. The building in question was inspected by DO, H.L. Aneja and ADO, P.S. Dahiya on 23,8.2011 with a view to insure the compliance of fire safety guidelines on accordance with the Delhi Fire Service Act 2007 & Rules 2010, provisions contained in NBC of India (Part-IV). Mr. Sukhdev Singh was also present.

During the course of inspection it was observed that the guest house is running in a four storeyed building comprised of basement, ground floor plus three upper floors on a total plot area of approx 167sq.mtrs. The covered area of the basement is approx. 125sq.mtr. The building is prior to enforcement of Delhi Fire Service Act. 2007. Rules 2010. The basement is served by two staircases and the upper floors are served by single stair case of 126cms, width. The building is located on the road having direct approach to the fire fighting vehicles. The electric wiring were seen concealed, the electric is passed through MCB's and the building is properly ventilated. The height of the building is 14.90mtrs, as per affidavit submitted by the owner. The detail of rooms/ occupancy at various floors was observed as under-Basement

Using as storage. Ground Floor Reception & Hall. First Floor Five Guest rooms. Second Floor Five Guest rooms. Third Floor Five Guest rooms. Terrace Pantry in temporary shed.
