ORDER

In continuation of this order No. F.2/DFS/HQ/2009/2631 dated 14.09.2010 and consequent order No. F.2/DFS/HQ/2009/ dated 18.05.2010 and in compliance with the order of Hon'ble Supreme Court of India dated 09.02.2009 in S.L.P. (Civil) No. CC/1281/2009 titled as Govt. of NCT of Delhi & Others Vs Association of Fire Service (Drivers), Delhi vide which judgment of Hon'ble Court of Delhi dated 13.05.2008 in the WP(C) No. 6194/2001 has been upheld for the grant of promotion to Grade-I in the pay - scale of Rs. 1600-2660 (Pre-revised) to the drivers who have completed 10 years of regular service in the pay - scale of Rs. 1320-2040 and on the roll of DFS as on 01.01.94.

Accordingly, the drivers who have been retired and admissible for the benefit of Grade-I on the basis of trifurcation of drivers who were in service in the year 1994 w.e.f. the date mentioned against their names:-
