

May kindly see the letter No. RJS/87/2011 dated 06-06-11, received from the Principal, Ramjas School (Primary Section), located at Anand Parbat, New Delhi -110005, regarding issue of NOC from fire safety and means of escape in respect of above school.

In this connection it is stated that the school building in question was inspected by undersigned on 22.06.2011 with a view to ensure the compliance of the Fire Safety guidelines on accordance with the Delhi Fire Service Act 2007 and Rules 2010, provisions contained in NBC of India (Part-IV). Mrs. Rajni Arora was also present.

During the course of inspection it was observed that the school building (Primary Section) is comprised of ground floor only. The building is approachable to the fire fighting vehicles. The electrical wiring was seen concealed and the electric supply was passing through MCB's. The building is properly ventilated. The rooms allocation in the school is as under:-

Ground floor – Admin block, Computer lab, Examination room, General science labs, Audio visual room, Gym hall, Store and class rooms etc. (total 30 rooms).

The school building is protected by the following fire safety arrangements as under:-
