NOTIFICATION

In exercise of the powers conferred under section 511 (B) of the Delhi Municipal Corporation Act, 1957 as amended from time to time read with the Government of India, Ministry of Home Affairs' notification No.F.U.14011/187/95-Delhi dated 10th November, 1994, the Lt. Governor of National Capital Territory of Delhi is pleased to order the transfer of the services of the Officers and employees of Delhi Fire Service from the Municipal Corporation of Delhi to the Government of N.C.T. of Delhi on the following terms and conditions:-

a) That all the technical officers and employees of Delhi Fire Service viz., Operational Wing, Workshop, Wireless Control Room and others as mentioned in Schedule 'A' appended to this notification, shall be absorbed permanently in the Government of N.C.T. of Delhi with effect from the date of transfer of Delhi Fire Service from M.C.D. to the Government. i.e. 10-11-1994. The absorption shall be subject to the rules/regulations applicable to the employees of the Government of N.C.T. of Delhi.

b) That the officers and employees of General Wing of D.F.S. working against the posts as mentioned in Schedule 'B' to this notification shall be transferred on deputation basis with the Government of N.C.T. of Delhi initially for a period of one year from the date of transfer of Delhi Fire Service to the Government of Delhi i.e. with effect from 10-11-1994. These officers and employees shall submit their option for permanent absorption in the Government or for repatriation to the M.C.D. on or before 10-6-1995. In case, any officer and employee fails to submit his option within the prescribed time limit, it shall be construed that he has opted for permanent absorption in the Government.

- c) That the absorption of the above officer and employees in the Government shall be subject to the rules and regulations applicable to the employees of Government of N.C.T. of Delhi issued in that behalf by the Government from time to time.
- d) That cases of officers and employees not working in the Delhi Fire Service on regular basis on the day of the transfer shall be considered for regularisation against their posts as per the extant recruitment rules/government guidelines on the subject issued from time to time. In the event of any officer and employee not being regularised within the framework of recruitment rules/guidelines, he shall be reverted to the M.C.D. and would continue to be the employee of the Municipal Corporation of Delhi.
- e) That the G.P.F. accounts of all the officers and employees permanently absorbed in the Government of Delhi by the M.C.D. and shall be maintained by the Pay & Accounts Office of the Government of N.C.T. of Delhi.
- f) That the pro-rata pensionary and other contribution in respect of each officer and employees permanently absorbed in the Government of N.C.T. of Delhi shall be made by the Municipal Corporation of Delhi.
