The up-gradation is further subject to the following conditions:-

- (a) Pay & Allowance of the incumbents will be fixed under the provisions of FR-22(I) a (1) subject to the terms & conditions contained in Director (A&P)'s Circular No. DJB/AC(W)/ACP/99/7377 dated 30.11.1999 and further clarified vide circular No. DJB/AC(W)/2000/29263 dated 11.5.2000. The officials concerned may be allowed to exercise their options, if any, under FR-22 within one month of the issue of the order, granting the financial up-gradation under the ACP scheme.
- (b) At the time of fixation of pay of the above employee, the DDO will again confirm that the officials have completed at least 12 years of regular service with no promotion for grant of 1st up-gradation, since the date of initial appointment in their services.





- (c) The financial up-gradation is merely placement in higher pay scale and this does not amount to functional/regular promotion or seniority benefit etc.
- (d) The financial up-gradation is subject to verification of Audit.
- (e) The DDOs will verify that the employees recommended for financial up-gradation were not under currency period of penalty. On the date from which financial up-gradation has been recommended/allowed to him.
- (f) Work charged staff transferred from the DDA, if any, in the list shall be dealt with according to AC(G)'s circular No. DJB/AC(G)/DDA/05/25323 dated 2.3.2005.
- (g) The above incumbents would be placed in the revised grade pay as per 6th CPC w.e.f. 1-09-2008 as per the guidelines contained in Dy. A&FO-I circular dated 30-04-2010 subject to fulfillment of terms and conditions.
