Subject:- Introduction of new procedure for applying online for Indian Citizenship. I am directed to inform that the Ministry of Home Affairs, Govt. of India's letter No.

26030/33/2010-IC.I dated 24th Nov., 2010 (copy enclosed) has intimated that the Ministry has instructed a new procedure for applying online Indian citizenship. The Ministry has developed a software to facilitate submission of online applications for grant of Indian citizenship. The applicant can make application online for quick processing of the same by the concerned Dy.

As you are aware, the citizenship Act, 1955 provides for acquisition of Indian citizenship by birth, descent, registration and naturalization and as per existing procedure already available under Rule 11 & 12 of the Citizenship Rules, 2009, an application for registration under section 5 or naturalization under section 6 of the Citizenship Act, 1955 is made to the Collector/Dy. Commissioner/District Magistrate within whose jurisdiction the applicant is ordinarily resident. The application alongwith a report of the eligibility and suitability of the applicant is to be sent with your recommendation to the Home Department, within a period of sixty days.

You are, therefore, requested to give wide publicity of the aforesaid procedure and ensure that applications for grant of Indian Citizenship are made only online.
