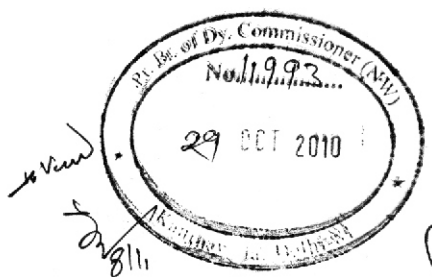

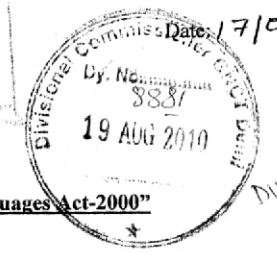

- e) Proceedings of Legislative assembly will be recorded and issued simultaneously in Urdu and Punjabi also wherever required.

Accordingly, it is requested to ensure the implementation of the said act by all Government Department /Offices/Autonomous Bodies/Local Bodies. In case assistance of this Department is required for Urdu/Punjabi translations, the services of empanelled translators/agencies on payment basis can be provided.


