In compliance of the directions passed on 28.10.2010 by the Hon'ble CAT in the matter of Smt. Vijay Vs GNCT of Delhi in TA No.1469/2009 and on the recommendations of the Departmental Promotion Committee held on 18th April, 2011, Smt. Vijay (DOB 05.05.1965), Assistant Teacher (Nursery) of MCD is hereby, promoted to the post of TGT Social Science in the pay scale of Rs.9300-34800/- + Grade Pay Rs.4600/- (as per 6th Pay Commission) plus usual allowances as admissible as per rules. The promotion of above recommended candidate is further subject to the condition that the said teacher fulfill the educational requirements as laid down in Recruitment Rules for the post of TGTs/TGTs(MIL) and is further subject to the condition that there is no vigilance case/departamental enquiry pending/disciplinary proceedings/penalty is in operation against the teacher concerned at any level.

In case of any discrepancy is noticed in respect of above mentioned promoted teacher, the matter may be brought to the notice of E-III branch of this directorate where it will be examined. Such teacher may not be relieved till the receipt of clarification from E-III branch. The seniority of the teacher will be assigned as per rules in the light of the directions of Hon'ble CAT and the serial number assigned in the promotion order doesn't necessarily reflect her seniority as TGT/TGT (MIL). In case of teacher found ineligible for promotion as per RRs or not having vigilance clearance, their promotion order may be cancelled.

The Establishment III Branch of Directorate of Education is hereby, directed to check the requisite documents received from the candidate and to obtain fresh Vigilance Clearance Report/IC/VC of the above mentioned teacher from MCD in a time bound manner. If the requisite qualification(s) has been obtained after joining the service, it may be checked that due approval of the Competent Authority has been obtained. After checking the eligibility as per RRs for the said post and Vigilance Clearance, the Estt.-III branch of this Directorate shall generate Appointment Order of the teacher which will be issued on-line through MIS.





The concerned MCD authorities are requested to direct Smt. Vijay, Assistant Teacher (Nursery) of MCD to contact Estt- III Branch of this Directorate at Room No.222, Estt.-III Branch, Old Sectt., Delhi - 54 within 10 days from the date of issue of this order for submission of her willingness to join promotional post and verification of relevant documents in Directorate of Education, GNCT of Delhi.
