Consequent upon selection on provisional basis through Delhi Subordinate Services Selection Board for recruitment to the post of TGT(Punjabi) and with the prior approval of the Competent Authority, the following candidates are hereby appointed purely on provisional basis to the post of TGT(Punjabi) in the Pay Scale of Rs.9300 - 34800 with Grade Pay of Rs. 4600 (pre-revised scale of Rs.5500-175-9000) plus usual allowances as admissible under G.N.C.T. of Delhi from time to time subject to usual terms and conditions given in the offer of appointments and accepted by them. They are further directed to report to their place of posting latest by 01/08/2011 failing which it will be presumed that she is not interested in joining the post to which she has been appointed and her appointment shall stand cancelled without any further communication. These appointments are temporary and subject to probation period for a period of two years and further subject to verification of character and antecedents by the Deputy Director of Education concerned. They have been medically examined by the concerned hospital and declared fit vide their individual report placed in their dossiers. These appointments are also subject to verification of documents/certificates including caste and Physically Handicap Certificate, by the concerned DDE on joining the school.
