

Consequent upon selection on provisional basis through Delhi Subordinate Services Selection Board for recruitment to the post of TGT(Maths) and with the prior approval of the Competent Authority, the following candidates are hereby appointed purely on provisional basis to the post of TGT(Maths) in the Pay Scale of Rs.9300 - 34800 with Grade Pay of Rs. 4600 (pre-revised scale of Rs.5500-175-9000) plus usual allowances as admissible under G.N.C.T. of Delhi from time to time subject to usual terms and conditions given in the offer of appointments and accepted by them.
