They are further directed to report to their place of posting latest by 23/09/2011 failing which it will be presumed that he is not interested in joining the post to which he has been appointed and his appointment shall stand cancelled without any further communication. These appointments are temporary and subject to probation period for a period of two years and further subject to verification of character and antecedents by the Deputy Director of Education concerned. They have been medically examined by the concerned hospital and declared fit vide their individual report placed in their dossiers. These appointments are also subject to verification of documents/certificates including caste and Physically Handicap Certificate, by the concerned DDE on joining the school.
