Consequent upon selection on provisional basis through Delhi Subordinate Staff Selection Board for recruitment to the post of Physical Education Teacher and with the prior approval of the Competent Authority, the following candidate is hereby appointed purely on provisional basis to the post of Physical Education Teacher vide Post code- 18/2010 in the pay scale of Rs. 9300- 34800 with Grade pay of Rs. 4600/- plus usual allowances as admissible under the rules from the time to time subject to usual terms and conditions given in the offer of appointment and accepted by him/her. He/she is further directed to report his/her place of posting latest by 15/09/2011 failing which his/her appointment shall stand cancelled without any further communication. This appointment is temporary and on provisional basis for two years and further subject to verification of character and antecedents by the DDE concerned. He/she is exempted from the Medical Examination for appointment to the post of PET as he/she had already been medically examined at Lok Nayak Jai Prakash Hospital, New Delhi and declared "FIT" while entering in Govt. Service(Delhi Prison) and the certified copy of the same has been received from the Superintendent, Central Jail, Tihar, New Delhi. The Medical Fitness report has been placed in his/her dossier. The appointment is also subject to verification of qualification/documents/certificates and caste certificate by the concerned DDE on joining his/her respective school. This appointment would be subject to the outcome of the 02 petitions, filed before the Hon'ble CAT vide OA No.- 1206/2011 and 1618/2011 titled " Monika Yadav & Anr. Vs GNCT of Delhi & Ors." and "Mukesh Vats & Anr. Vs GNCT of Delhi", who appeared in the examination, conducted by DSSSB for the post of Physical Education Teacher.
