

Consequent upon selection on provisional basis through Delhi Subordinate Services Selection Board for Recruitment to the post of Physical Education Teacher and with the prior approval of Competent Authority, the following candidate is hereby appointed purely on provisional basis to the post of Physical Education Teacher vide post code -18/2010 in the Pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4600/- plus usual allowances as admissible under the rules from time to time subject to usual terms & conditions given in the offer of appointment and accepted by him/her. He/She is further directed to report to his/her place of posting latest by 25/11/2011, failing which his/her appointment shall stand cancelled without any further communication. This appointment is temporary and on provisional basis for two years and further subject to verifications of character and antecedents by the DDE concerned. He/She has been medically examined by the Medical Supdt., Dr. Baba Saheb Bhim Rao Ambedkar Hospital/LNJP Hospital and declared medically FIT vide their letter dated 10/10/2011 & 31/01/2006 respectively.
