ORDER

In continuation of order No.F.DE/ACT/2010/7211-7222 dated 15/12/2010 and its corrigendum dated 16/12/2010 and the provisions made in Notification No. 15(172) / DE / Act/2010/69 dated 07.01.2011 with regard to Delhi School Education (Free seats for students belonging to Economically Weaker Section & Disadvantaged Group), the following admission schedule and guidelines are issued for conducting admissions to Pre-School/Pre-Primary/Class-I classes (entry level) for academic session 2012-13:

ADMISSION SCHEDULE

A school can deviate from the above schedule depending on the specific circumstances. However, no deviation shall be permitted regarding dates of commencement and closure of admission i.e. 02.01.2012 and 31.03.2012, respectively and, therefore, all schools shall have uniform dates for commencement and closure of admission process.

In case of deviation from the above schedule (except the dates of commencement and closure of admission i.e. 02.01.2012, and 31.03.2012 respectively), the school shall intimate it to office of the Director of Education, through the concerned Deputy Director of the District by 16:00 hours on 31.12.2011. The intimation shall invariably be accompanied by reasons for the deviation. In the absence of any intimation, the school shall be bound by the schedule laid down in this order.

Each school shall display the admission schedule on its notice board/website and also on official website of Directorate of Education through the link provided by the Department.

The Directorate of Education has devised a Common Admission Form for admission under Economically Weaker Section & Dis-advantaged Group category and the same is uploaded on the official website of Directorate of

Education i.e. <u>www.edudel.nic.in</u> for the benefit of the schools as well as the applicants. All the schools are directed to use the same format <u>only</u> by downloading the application form or by using a printed application form. Parents may get Common Admission Form from the schools or may download from the above said website. Every school shall ensure that within the above admission schedule, the application forms in the prescribed proforma are made available free of cost to all applicants under EWS and Disadvantaged Group, without any barrier/hindrance.

All schools shall ensure that no child under Economically Weaker Section & Disadvantaged Group is denied admission on neighbourhood/distance basis so long as the locality of the child's residence falls within the distance criterion devised by the school for the General category children.

After the closure of admission process on 31-03-2012, each school shall send the details of the number of vacant seats under Economically Weaker Section & Disadvantaged Group to the concerned District Dy. Director of Education by 16: 00 hours on 06-04-2012. The concerned districts will compile the school-wise status of such vacant seats under EWS and Disadvantaged Group category and forward the same to the Act Branch at HQs latest by 10-04-2012 so that necessary steps to fill all the vacant seats can be taken.
