ORDER

Sh. R. P. Mehto, Driver has filed an appeal for revocation of the cancellation of his Driving License under Section 19 of Motor Vehicle Act 1988. The brief of the case is that the ACP (Traffic) E Distt. has informed this office that one Sh. R. P. Mehto S/o Ram Chander H.No.86, Haider Pur, Delhi-110088 having Driving License No.C08092001261383 issued on 13/12/2007 from North-West Zone of the Transport Department, GNCTD has caused a fatal accident while driving a bus bearing registration No.DL1LE 6142 rashly and negligently at Dabrimode F.I.R. No.657/05, dated 04/10/2005 U/s 279/304-A IPC. P.S Tilak Nagar. Therefore he recommended that the driving license of the above said person as per law may be cancelled / suspended.

Accordingly after issuing a notice to Sh. R. P. Mehto and, The above said license was cancelled by M.L.O.(HQ)

Sh. R. P. Mehto, state that he has no more required for trial purpose in this case of all the charges framed against him by the Hon'ble Court of Sh. Rajesh Maliki, Metropolitan Magistrate, District West, Tis Hazari Court Delhi and a copy of the judgment has been filed.

Under the circumstances narrated above, I am of the view that the ends of the justice will be met by revoking the order of cancellation of the driving license of Sh. R. P. Mehto, so as to enable him to earn his livelihood.

Sh. R. P. Mehto, has undertook to remain vigilant and careful about the public safety and always drive the vehicles safely.
