OFFICE MEMORANDUM

**SUBJECT- PARTIAL MODIFICATION IN DELHI GOVERNMENT EMPLOYEES HEALTH SCHEME.**

Delhi Government Employees Health Scheme was formulated for serving employees/pensioner of Govt of National Capital Territory of Delhi in 1997. The scheme was communicated vide letters No. F.No. 27(9)/96-M&FW dated 26/09/1997. The scheme was last revised vide O.M. No. F. 25(III)/DGEHS/140/DHS/09/38850-38862 dated 28/07/2010.

Consequent to review and rationalization of different provisions and procedures of the Delhi Government Employees Health Scheme, the following provisions / modifications have been approved by the Council of Ministers vide cabinet decision no. 1858 dated 23/01/2012 communicated vide letter no. F.3/2/2011-GAD/CN-407-418 dated 24/01/2012 for better implementation of the scheme.

- 1) **Medical Facilities to dependant family members of Ministers, MLAs, Ex. MLAs and Metropolitan councilors** - Dependant family members of the Ministers of Government of NCT of Delhi and of Sitting as well as Ex. MLAs of Delhi Legislative Assembly will be allowed treatment on cashless basis in the empanelled private hospitals/diagnostic Centers. The payment to empanelled hospitals / diagnostic centers for such cashless treatment will continue to be made by GAD in case of Ministers and their dependents and Delhi Legislative Assembly in case of Sitting as well as Ex. MLAs and their dependents. In addition Ex. Metropolitan Councilors of Delhi and their dependent family members be treated as Ex MLAs in respect to DGEHS facility and accordingly be eligible to same benefits as Ex MLAs under the DGEHS. The expenditure on this account will be made by the Delhi Legislative Assembly.

- 2) **Medical Facilities to Judges of Hon'ble High Court of Delhi** - Sitting as well as retired Judges of High Court of Delhi will be allowed direct entitled treatment for self and dependent family members in empanelled private hospitals/diagnostic centers.
- 3) **Medical Facilities to heads of the departments, IAS officers (AGMUT) and DANICS officer** - All heads of the departments / Heads of the autonomous bodies under GNCT of Delhi, Senior officers i.e. IAS officers (AGMUT) and DANICS officers (JAG and above in the pre revised pay scale of Rs. 12000-16550 corresponding to present grade pay of Rs. 7600 & above or equivalent) do not need authorization / permission for entitled treatment for self and dependent family members in private recognized hospitals. Since the facility of direct entitled treatment for self and their family members from private recognized hospitals is available during service of these officers therefore the same facility will continue to be available to them and their dependents even after retirement from these posts. This facility shall be available to officers of above mentioned categories who have already retired from the service.
- 4) **Medical Facilities to IAS and DANICS Officers posted outside Delhi** - The Indian Administrative Service Officers (AGMUT) and DANICS Officers when posted out of Delhi (Transfer / Deputation) will be given an opportunity to exercise an option as to whether to continue under DGEHS or they want to become member, and will be extended the facilities of DGEHS in respect of self and their family members who continue to stay in Delhi. This would be subject to the condition that the families of such Indian Administrative Service (AGMUT)/DANICS officers would be allowed to avail of the DGEHS facilities provided the officer certifies that his/her family is residing in Delhi/NCR and that he/she pays charges applicable (related to his pay scale) towards contribution for availing of DGEHS facility. The officer concerned should either avail the facility in Delhi or headquarters – not both, even though they may be members of health scheme in place of posting. Double benefit cannot be availed.



In the event of retirement of such officer, he would be treated as a pensioner under the scheme provided he opts for the same. The facility will continue even in the tragic death of such an officer while he is posted outside Delhi provided his family would have been entitled for continued benefit under DGEHS if the said officer has been posted in Delhi. The cashless facility to such families will be provided during the period the officer is posted outside Delhi. The claim shall be processed by the H&FW Department. Health Card showing "Cashless Facility available" shall be issued for beneficiaries and their dependents for defined period from the H&FW Department.

The above provisions will be applicable with immediate effect.
