During the course of inspection it was observed that the school building is comprised of ground floor plus one upper floor. The electrical wiring was seen concealed and the electric suply was passing through MCB's. The building is properly ventilated. The room allocation in the school is as under :-

Fire Extinguisher Co₂ type fire extinguisher of 2.5 Kg. cap. And ABC type fire extinguisher of 5 Kg. Capacity are provided in the building as per above said circular.

The Fire Extinguishers were checked and the performance found satisfactory at the time of inspection. In view of the above the school premises may be considered safe from Fire Safety point of view for grant of Fire Safety Certificate for running the school in above said building.
