If anything found adverse about his /her educational certificates, caste certificates, character and past antecedents, his/her services shall liable to be terminated.
4. That his/her engagement is further subject to the satisfactory work & conduct report during the period of service.
5. If he/she remains absent from her/him duty more than 30 days or more continuously without any information /permission, his /her services are liable to be terminated.
6. He /She will get himself/herself registered as Member of Delhi Building and construction workers welfare Board within three months of the appointment for which AD (P&M) of the DJB will assist as Nodal Officer.
7. In case he/she is already employed, he /she should produce a No Objection Certificate/relieving report from the previous employer.
