In continuation of this office Memorandum No. DJB/AC(G)-I/C.G-12/2012 /50365 to 68, Sh. Chander Pal Singh S/o Late Sh. Chet Ram Singh R/o H. No. J-III-367, Wazirpur J.J. Colony, Ashok Vihar, Delhi-52 has accepted the post of Chowkidar on Muster Roll on Compassionate ground with the terms and conditions. Accordingly, he is hereby engaged and posted with EE(N.West)-III with immediate effect with subject to following terms and conditions:-

1. He will be governed by the rules and regulations as applicable to the other Muster Roll workers of Delhi Jal Board.
2. He will maintain the dependent/family of the deceased employee.
3. His engagement will further be subject to Verification of Educational and Caste Certificate and to the condition that nothing is found adverse about his character and antecedents, which will be got done by DDO concerned within three months of his engagement. If any thing is found adverse about his character and past antecedents, his services shall liable to be terminated.
4. His engagement is further subject to the satisfactory work and conduct during the period of service.
5. He will not remain absent from duty for 30 days or more continuously, without prior approval of his controlling officer.
6. His pay will be fixed according to rules of M/Roll employees.
7. He will fit for the post as mentioned against each. If, he will not found fit for the post then his service is to be terminate without further notice.
8. In case of failure on any of the above counts, M/Roll engagement shall liable to be terminated without notice.

**Note:-** DDO is also hereby directed to complete the following formalities that:-

1. Check the original certificate of educational qualification and other certificate, if any, before taking him on duty.
2. Direct to individual to appear before the Medical Officer in DJB Dispensary for Medical examination with in 60 days and send the photocopy of MOI report to the Admn.
