The up-gradation is further subject to the following conditions:-

- (a) Pay & Allowance of the incumbents will be fixed under the provisions of FR-22(I) a (1) subject to the terms & conditions contained in DOPT O.M. No. 35034/3/2008-

Estt. (D) Dated 19-05-2009 respectively. The officials concerned may be allowed to exercise their options, if any, under FR-22 (I) a (1) within one month of the issue of the order, granting the financial up-gradation under the MACP scheme.

- (b) At the time of fixation of pay of the above employee, the DDO shall again confirm that the concerned officials either have completed 10 years of regular service or he has spent 10 years continuously in the same grade pay for grant of benefit of 1st financial up-gradation under MACP Scheme without any break or unqualified service.
- (c) The financial up-gradation is merely placement in higher pay scale and this does not amount to functional/regular promotion or seniority benefit etc
- (d) The financial up-gradation is subject to verification of Audit.
- (e) The DDOs will verify that the employees recommended for financial up-gradation were not under currency period of penalty. On the date from which financial up-gradation has been recommended/allowed to him.
- (f) The DDO concern shall also ensure/verify that none of the employee recommended by DSC has been granted any in-situ or other financial up-gradation under ACP scheme/promotion respectively.
