Further, they have been declaired "Medically fit" for the post as mentioned against each by DJB's MOIs concerned and they are subsequently posted with the DDOs concerned where they are presently working as Beldar / Safai Karamchari on Muster Roll.

Their character & past antecedents, educational certificate & caste certificate be got verified by the DDOs concerned at their own level within 06 months from the issueing authorities. The copy of verification report be sent to this office. In case the particulars of educational qualifications and caste certificate of the following individuals have already been got verified from respective authorities then there is no need to conduct a fresh verifications. Further, original certificates of educational qualifications, proof of age, caste certificates, muster roll records, medical fitness reports etc. be also checked by their DDOs concerned before taking them on duty. Attested copies of educational certificates, proof of age, original muster roll books and medical fitness reports must be placed in P.F. &. S. Book of the individuals. The above appointment shall further be subject to verification of attendance from original paid Muster-Rolls of the individuals by the concerned AAO/AO.
