WHEREAS the workman Sh. Anish Kumar S/o. Sh. Mukhtiar Singh was appointed as S.C.M. Driver in the pay scale of 950-1400 on 28.12.89, against a direct recruitment vacancy. Subsequently, it was revealed that the adequate number of vacancies were not available in that grade and after issuing a proper show cause notice to him, he was removed from the services of the erstwhile Delhi Water Supply & Sewage Disposal Undertaking (now DJB) vide O.O No. 257(Dist.) CSE dated 10.09.1990.

AND WHEREAS the individual challenged the above removal order by filing a civil suit and lost the same vide civil court order dated 31.05.96. Being prejudiced, the workman further appealed before Addl. Distt. Judge and succeeded in obtaining the order in his favour i.e. reinstatement and grant of back wages.

AND WHEREAS in the execution petition filed by the workman before the Addl. Distt. Judge Sh. R.K. Tripathi, also got the conditional order vide dated 03.06.2005 and received a sum of Rs. 8,13,071/- (Eight Lac Thirteen Thousand and Seventy One Only) with the undertaking to refund the amount to the department in case he loses the case before the Hon'ble High Court.

AND WHEREAS in the second appeal before the Hon'ble High Court the workman lost the case and the Hon'ble High Court vide order dated 15.12.10 was pleased to set aside the order of the lower court and allowed the appeal filed by the department, and thereafter, the workman approached to the Hon'ble Supreme Court of India by filing one SLP, which has been withdrawn by him and thereafter a review was preferred by the workman which ultimately was dismissed by the Hon'ble High Court.



Consequent upon the series of litigations and the orders passed by the various courts, the order of the Hon'ble High Court dated 15.12.2010 became the determining factor on which the action is required to be taken by the department, and by virtue of the order of the High Court the workman forfeits the legal right to continue in the service of DJB and the amount of Rs. 8,13,071/- (Eight Lac Thirteen Thousand and Seventy One Only) conditionally accepted by him should be deposited within 30 days alongwith interest @12% (P.A.) from the date of receipt of this order.

Now therefore, Sh. Anish Kumar is hereby, removed from the services of Delhi Jal Board with immediate effect and he is directed to deposit the above said amount i.e. Rs. 8,13,071/- within a period of 30 days alongwith interest (a) 12%(P.A.) from the date of receipt of this order, failing which legal action will be initiated against him.
