Consequent upon the recommendations of the Departmental Screening Committee and approval of the Competent Authority, Sh. Ramesh Chander S/o Sh. Chattar Singh (Emp. No. 40006104), Carpenter 2<sup>nd</sup> Class C/o EE © Plant, WW is hereby granted 1<sup>st</sup> financial up-gradation under ACP Scheme w.e.f. 17-02-2002 in the pay scale of Rs. 4000-6000 (pre-revised) subject to the following conditions:-

- (a) Pay & Allowance of the incumbent shall fix under FR-22(1) (a) (i) on 22.4.2005 and on 15.7.2008 under FR-22 (1) (a) (ii) subject to the terms & conditions contained in Director (A&P)'s Circular No. DJB/AC(W)/ACP/99/7377 dated 30.11.1999 and further clarified vide circular No. DJB/AC(W)/2000/29263 dated 11.5.2000. The official concerned may be allowed to exercise his option, if any, under FR-22 within one month of the issue of the order, granting the financial up-gradation under the ACP scheme.
- (b) At the time of fixation of pay of the above employee, the DDO will again confirm that the official has completed at least 12 years of regular service with no promotion and 24 years regular service with one promotion or financial up-gradation for grant of 1<sup>st</sup> and 2<sup>nd</sup> up-gradation respectively, since the date of initial appointment in his service.
- (c) The financial up-gradation is merely placement in higher pay scale and this does not amount to functional / regular promotion or seniority benefit etc.
- (d) The financial up-gradation is subject to verification of Audit.
- (e) The DDO will verify that the employee recommended for financial up-gradation was not under currency period of penalty. On the date from which financial up-gradation has been recommended / allowed to him.
- (f) Work charged staff transferred from the DDA, if any, in the list shall be dealt with according to AC(G)'s circular No. DJB/AC(G)I/DDA/05/25323 dated 2.3.2005.
