(a) Pay & Allowance of the incumbents will be fixed under the provisions of FR-22(I) a (1) subject to the terms & conditions contained in Director (A&P)'s Circular No. DJB/AC(W)/ACP/99/7377 dated 30.11.1999 and further clarified vide circular No. DJB/AC(W)/2000/29263 dated 11.5.2000. * exercise their options, if any, under FR 22 within one month of the issue of the order, granting the financial up-gradation under the ACP scheme.

- (b) At the time of fixation of pay of the above employee, the DDO will again confirm that the officials have completed at least 12 years of regular service with no promotion and 24-years regular service with one promotion or financial up-gradation for grant of 1st and 1Ind up-gradation respectively, since the date of initial appointment in their services.
- (c) The financial up-gradation is merely placement in higher pay scale and this does not amount to functional/regular promotion or seniority benefit etc.
- (d) The financial up-gradation is subject to verification of Audit.
- (e) The DDOs will verify that the employees recommended for financial up-gradation were not under currency period of penalty. On the date from which financial up-gradation has been recommended/allowed to him.
- (f) Work charged staff transferred from the DDA, if any, in the list shall be dealt with according to AC(G)'s circular No. DJB/AC(G)I/DDA/05/25323 dated 2.3.2005.
