- (1) Pay & Allowance of the incumbents will be fixed under the provision of FR-(22) subject to the terms & conditions contained in DOP&T OM. No. 034/3/2008Estt (D) dated 19.05.2009 respectively. The official concerned may be allowed to exercise their options, if any, under FR-22(I) a (1) within one month of the issue of the order, granting the financial up-gradation under the MACP Scheme.
- (2) At the time of fixation of pay of the above employee, the DDO shall again confirm that the concerned officials either have completed 10/20/30 years of regular service or he has spent 10 years continuously in the same grade pay for grant of benefit of 1st/2nd/3rd/ financial upgradation under MACP scheme without any break or unqualified service.
- (3) The financial up-gradation is merely placement in higher pay scale and this does not amount to functional/regular promotion or seniority benefit etc.
- (4) The financial up-gradation is subject to verification of Audit.
- (5) The DDOs will verify that the employees recommended for financial up-gradation were not under currency period of penalty. On the date from which financial up -gradation has been recommended/allowed to him.
- (6) The DDOs concerned shall also ensure/verify that none of the employee recommended by DSC has been granted any in-situ or other financial up-gradation under ACP scheme/promotion respectively.
