Whereas Sh. N.R. Narain, DANICS has joined this Board on 1.9.2011 (F/N) as Deputy Director on deputation and opted the pay scale of Rs. 15,600-39,100/- plus Grade Pay of Rs. 6,600/- vide his option dated 14.9.2011.

And Whereas, as per notification dated 19.1.12 from Ministry of Home Affairs, Govt. of India forwarded by the Services Department vide letter No. 30/3/2010/S.I/1772-84 dated 7.3.2012 regarding appointment of feeder grade officers from the GNCT of Delhi and Andaman & Nicobar Islands Administration to the entry grade of NCT of Delhi, Andaman & Nicobar Islands, Lakshadweep, Daman and Diu and Dadra and Nagar Haveli Civil Services (DANICS), Sh, N.R. Narain has been granted the pay scale of Rs. 9,300-34,800/- plus Grade Pay of Rs. 4,800/-.

And Whereas, the LPC of Sh. N.R. Narain, which he has signed and issued himself mentions the pay scale of Rs. 9,300-34,800/- with Grade Pay of Rs. 5,400/-.

And Whereas, on perusal of the LPC it is found that the LPC has been signed and issued by Sh. N.R. Narain himself as DDO, Central District, Labour Department, GNCT of Delhi on 14.9.2011, i.e. 14 days after the date of his relieving from the said department on 1.9.2011, which is highly irregular and illegal and has therefore acted in a manner of unbecoming of a Govt. servant thereby violating Rule 3 of CCS (Conduct) Rules, 1964 that may lead to initiation of disciplinary proceedings against him under CCS(CCA) Rules, 1965.

Now, therefore, Sh. N.R. Narain is hereby repatriated and relieved with immediate effect with the direction to report to the Services Department, Govt. of NCT of Delhi for further orders.
