## **ORDER**

Sh. As Mohammed r/o 42, Hauz Khas Village, New Delhi-16 had filed an RTI application dated 27.9..2012 before PIO ,seeking information about certain queries with reference to entries recorded in the Visitors Register of this office in respect of Sh. Mahender .

Sh. M.K. Naunihal, APIO vide letter No. F.11(1)/DC/ND/RTI (HQ)/2011/9808 dated 19.11.2012 had forwarded a authenticated copy of Visitors Register to the applicant in response to information sought by him

Now, As Mohammed has further filed an appeal vide his letter dated 14.11.2012, received in this office on 21.11.2012 to the undersigned/First Appellate Authority stating therein that he did not receive any reply for his RTI application dated 27.9.2012.

In this regard an hearing opportunity was given to appellant to appear on 17.12.2012 at 2:30 p.m. with a copy to Sh. M.K. Naunihal, Tehsildar(HQ) /APIO.

During the course of hearing, it was observed that APIO had sent him a reply vide his letter F.11(1)/DC/ND/RTI (HQ)/2011/9808 dated 19.11.2012 enclosing therewith a copy of page of Visitors Register (dated 25.5.2009), which has already been received by the appellant.

As there is no additional information available on office records except this Visitor's Regiter for 25.5.2009, the information provided by APIO is fully justified under the Right to Information Act, 2005.
