ORDER

16.11.2012:

Present : Sh. M.K. Naunihal, APIO but Sh. Hitesh Kumar , Appellant, is absent.

Sh. Hitesh Kumar r/o House No.7, Bharat Nagar, New Delhi-52 had filed an RTI application dated 01.8.2012 before PIO/RTI, Office of the Chief Secretary, GNCTD ,seeking information about details of penalties imposed on corrupt officials working in Revenue Deptt, Transport Deptt, Sales Tax, Food & Supplies , Land & Bldg. Department and GAD.

The said RTI application was forwarded by PIO of CS Office vide their letter No. F.3/18/CS/12 /ID No.1329/RTI/3169-3175 dated 6.8.2012 to the PIOs of all the relevant departments and subsequently the SDM-III(HQ)/PIO has forwarded this application to this office vide their letter dated 18.9.2012.

Sh. M.K. Naunihal, APIO vide letter No. F.11(1)/RTI/2011/5444-45 dated 03.10.2012 has communicated to the applicant that no such corruption related is pending or contemplated in New Delhi District and information in this regard may be treated as Nil.

Now, Sh. Hitesh Kumar r/o House No.7, Bharat Nagar, New Delhi-52 has further filed an appeal vide his letter dated 22.10.2012 , received in this office on 25.10.2012 to the undersigned/First Appellate Authority stating therein that he is not satisfied with the information provided by PIO/APIO.

In this regard an hearing opportunity was given to appellant to appear on 16.11.2012 at 2:30 p.m. and present his case before the undersigned .

During the course of hearing, the appellant did not attend the hearing and based on the records produced and information furnished by the APIO, Sh. M.K. Naunihal , it is apparent that there is no corruption related disciplinary case is pending or contemplated against any of official/officer working in New Delhi District and the information in this regard is -Nil-
