MINUTES OF THE MEETING

The members of the Advisory Committee were informed about the Advisory of Dr. S.C. Dhiman, Chairman, Central Ground Water Board received from the Office of the Chief Secretary, Delhi. In the said advisory following observations had been made :-

"It is observed that despite restriction on ground water withdrawal in all the districts of NCT of Delhi by Delhi Govt. the ground water levels are falling continuously in almost all the districts. The declining trend is alarming and the fall in water level is maximum in South and South-West Districts. Ground water regulation is being done through the District Advisory Committees under the Chairmanship of concerned DC of the district and during the year 2010-11 about 350 permissions were given for extraction of ground water by constructing bore-well/tube-wells. The Committees are concentration more on giving permissions as per the guidelines and not concentrating on regulations of illegal extraction of ground water leading to continuous fall in water level even after regulation. Therefore, suitable instructions may be given to all Chairman of the district advisory committees emphasizing to take active interest in stopping this unauthorized extraction to arrest the ground water level decline. Apart from regulation it is very much necessary to take ground water recharge measures on a large scale to control further decline of water levels"

In this background, following issues were discussed and decisions taken by the Committee :-

1. At the outset, the Advisory Committee discussed the issue of shallow boring for Rain Water Harvesting scheme being applied by the individuals/institutions. After deliberations, it was decided that henceforth no permission for shallow boring for Rain Water Harvesting scheme will be granted as the same is being misused for drawing ground water by the permission holders. It was decided, as advised by Central Ground Water Authority, that for water harvesting, applicants may be advised to make a pit of the dimension of 4mX2mX2m which will recharge ground water table. Alternatively, CGWA and Delhi Jal Board should jointly devise some design for this purpose. All the case are at Annexure-'B'



2. It was decided not to grant borewell permission to any individual applicant and they should be advised to approach Delhi Jal Board for meeting their water requirements.
3. Committee considered the request of the institutions/applicants seeking NOC for boring/re-boring tubewells in South-West District. The list of cases and the recommendations of the Committee is at **Annexure-'A'**
4. The Committee deliberated the cases of Delhi Jal Board where permission for few borewells has been sought by Delhi Jal Board. Committee was of the view that Delhi Jal Board, like other agencies, should also make provision for installation of Rain Water Harvesting. Priority should be given to Government buildings where there is no issue regarding availability of land.

1. Dalbir Singh, Executive Engineer(West-II), DJB submitted a request for grant of permission for four no. of borewells in the following area :-


- (1) In park near H. No. H-239, Naraina Vihar
- (2) In open space near H. No. WZ-667, Naraina Vihar
- (3) Near H. No. 417-A, Naraina Vihar
- (4) Inside compound of MCD school, C-Block, Inder Puri J.J.R.

As details of the existing Tube Wells in the nearby area was not available. However, the Executive Engineer(West-II), DJB impressed that there is urgent need for borewells because there is paucity of water in the area. In view of above, the Committee approved permission only for two borewells placed at Sl. No. 2 and Sl. No. 4 subject to condition at Delhi Jal Board will bring the details of borewell in this area particularly within 500 meters of the borewell, permission is being granted as requested.
