ORDER

Whereas a Kalandara u/s 133 CrPC has been received vide dy. No. RG/938 dated 28/01/2012 from SHO Rajouri Garden vide No. 116/SHO/PS/RG dated 09/01/2012 that an unauthorized construction at 1/168, Subhash Nagar, New Delhi is being carried out by you without obtaining any sanction/permission for the said activity from the Competent Authority.

And whereas a Conditional Order dated 06/02/2012 was issued by this court directing to appear before on 21/02/2012, but none appeared nor any written submission filed on behalf of respondent, another notice was issued to appear on 06/03/2012, but none appeared on this date also.

Under the provision of Section 133 Cr.P.C. (1)(d)- any building tent or structure, or any tree is in such a condition that it is likely to fall and thereby cause injury to persons living or carrying on business in the neighborhood or passing by, and in consequence the removal, repair or support of such building, tent or structure, or the removal or support of such tree is necessary.

As per above discussion, I am satisfied that the Conditional order issued on 06/02/2012 U/S 133 Cr.P.C. (ii) requiring respondent or owner/management to completely demolish the unauthorized structure at 1/168, Subhash Nagar, New Delhi is proper and reasonable. This order is made absolute on the above mentioned ground ex-parte.

Executive Engineer (Building) shall issue necessary direction to concerned AE and JE (Building) to book the property and take appropriate action (demolish/sealing of property) under the provision of Municipal Act and submit a report.
