ORDER

Whereas the above named complainant has made application to this court that respondent is indulged in unauthorized construction at third floor WZ-244/1 Plot No. VB/15, Virender Nagar, New Delhi-58 without obtaining any sanction/permission for the said activity from the competent authority.

And whereas none appeared on behalf of respondent and complainant in pursuance of Conditional order dated 5/10/11 and subsequent notice dated 18/10/2011. Kanungo of the sub division has reported that the premises has only ground floor, first floor and second floor. No construction at third floor has been noticed

In view of the above, I am of the considered opinion that no construction is being carried out at WZ-244/1 Plot No. VB/15, Virender Nagar, New Delhi-58.

As per above discussion, the Conditional order dated 5/10/11 is hereby discharged. However MCD may physically inspect the premises and ensure that no unauthorised construction is carried out at the above said premises. In case of deviations, MCD shall take appropriate action under the provision of DMC Act.
